

# Uniting Church Adult Fellowship

The Uniting Church Adult Fellowship (UCAF) has fulfilled a most productive service for the Church over the last three years. With the strength and guidance of the Holy Spirit, much has been accomplished throughout Australia and in other parts of the world and it gives me great pleasure to present this report to the 12<sup>th</sup> Assembly of the Uniting Church in Australia.

## Committee

In May 2006 at the 9<sup>th</sup> National Consultation held in Adelaide, a Committee from the Queensland Synod, consisting of eight women and two men was commissioned by the Assembly General Secretary, Rev. Terence Corkin as the UCAF National Committee for a term of three years.

The committee commissioned consisted of: President Mrs. Alyson Madsen, Vice-President Mrs Angela Lester, Secretary Mrs. Jan Akroyd-Bailey, Minute Secretary Mrs Chris Lloyd, Treasurer Mr. Barry Kerr, Chaplain Rev. Peter Arnett, Ecumenical/International Liaison Officer Mrs. Noela Schloss, and Committee members Mesdames Judy Kerr, Doreen Bengtson and Jean Dodd. Mrs Stephanie Kennedy was co-opted to the Committee as the Artistic Director for the Celebration.

## Theme

The theme for the triennium was "Let the Son Shine Through" and each affiliated group was challenged to use the theme in such a way that the Uniting Church could exhibit the love of God to the wider communities in which they live. This, in fact means, in excess of 18,000 women and men are witnessing to the people of Australia.

The special project commissioned by the 2006-2009 National Committee invited each Uniting Church member to knit, crochet, or sew a square from warm material. The squares were then sewn together to form rugs. The rugs are a symbol demonstrating the Son shining through us, in the uniqueness of each one of us and from all different situations and stations of life, and yet reflecting the combining fabric of the church.

During the three years just over 2,400 rugs (approx. 48,000 squares) were received. They came in all colours, sizes and textures, all made with the special love of Jesus. The rugs were dedicated at the Fellowship's National Celebration in Caloundra and then distributed through Uniting International Mission as well as other sources to areas of need throughout the world.

Rugs were forwarded, *free of cost*, to –

PNG Highlands – through Rotary International, Jindalee Branch  
Cambodia – Dorcus Program  
Solomon Islands – rugs for new born babies  
World Vision (Guardian Pharmacy) held for despatch  
Equestrian Group Members in Warwick as a result of the Equine Flu shut-down

In a very practical way, this will deepen our relationships with other denominations and with churches in Asia, the Pacific, Africa and indeed throughout the world. Continued support of Uniting Care, Frontier Services and Uniting International Mission is just part of the joyful work of the fellowship members and will continue to be for years to come.

## Assembly and Mandate

The Mandate for the National Committee is to plan, co-ordinate, and facilitate activities for its members under the approved Mission statement –

"To facilitate the network of Adult Fellowships nationally in order to promote the mission and witness of the Uniting Church in Australia."

There are approximately 18,000 members nationwide; they bring diverse gifts and are extremely loyal and committed to the service of the church; arguably, they are the "glue" which holds many congregations together. Each is the coming together of men and women for spiritual, social, educational, recreational, service, and mission support activities. These activities are organised at local level and work and report to each of the local Synod Committees. The National Committee has a co-ordinating role with these Synod Committees. The National Committee is supported financially by Synod Committee levies, based on membership, forming part of the budget passed at each triennial National Consultation.

The UCAF National Committee is an Agency of the Assembly but, unlike other Agencies, has no National Director, has only a nominal budget, and is comprised entirely of volunteers. We thank the Assembly for their assistance with portion of our administration costs.

The Committee was invited to contribute to the Assembly 2009 Mission Prayer Book and we thank Eva Donaldson (Queensland) for her devotional input on our behalf.

The National Committee is linked with, relates to, and pays affiliation fees to two world bodies: The World Federation of Methodist and Uniting Church Women (WFM&UCW) and the World Alliance of Reformed Churches (Department of Partnerships of Women and Men). Our Ecumenical Liaison member

corresponds with our thirty-three partner churches in the Pacific, Asia, India and Africa. Unfortunately we receive very little correspondence in return.

The National Committee is a member of "The President's Table" but, unfortunately during the triennium, attendance at functions has not been possible.

### **Conferences – South Pacific and World**

In May 2006 nine members attended the conference of the WFM&UCW held in Jeju Island, Korea. Some 2,000 women from around the world attended the Conference. Young women under 30 years of age who hold active roles in the Church and show potential leadership qualities are invited to be nominated to attend the World Federation gatherings as Helen Kim scholars. Two young women from each Area are selected. Eighteen other young women from around the world attended as the 2006 Helen Kim Scholars and it was a joy to have as one of our group, Rowena Connan (Victoria) who was a recipient of the Helen Kim Bursary in 2001

At the Conference the Australian contingent, on behalf of the Adult Fellowship members, agreed to embody the eight Millennium Development Goals of the United Nations and encourage all Fellowships to incorporate at least one of the Goals into their annual program.

Following this gathering, President Alyson Madsen joined with eleven others from the Uniting Church in Australia as delegates to the World Methodist Conference in Seoul, a gathering of some 3,500 Christians from all over the world in which it was indeed an honour and joy to participate. The diversity of spiritual expression, the challenges confronting many countries, the outward expression of faith, and the joining together for daily worship was an experience one will never forget.

In an act of reaching out to our near neighbours, and in particular our prayer partner, the Solomon Islands, the National Committee invited and paid for Pose Telasasa to join with us at the World Assembly. Pose found this experience rather exciting and in her own way brought another dimension to the discussions.

In September 2008 thirty-four Australians attended the South Pacific Area Seminar of the WFM&UCW held in Tonga. Further financial assistance was given to a number of our Solomon Island and Thursday Island friends to be part of this gathering.

One of our members, Ann Connan, is currently Vice-President of the South Pacific Area of WFM&UCW, and we give thanks for her leadership in the Bible Studies at the recent Conference in Tonga.

### **Working Procedures**

During the triennium, part of the responsibility of the National Committee is to arrange and organise a National Celebration.

Over a five-day period in September 2007 people from overseas as well as every State and Territory in Australia, attended the National Celebration held at

Rydgges Resort, Caloundra on the Sunshine Coast in Queensland. Dr. Val Webb was the Bible Study Leader, complemented by a number of Keynote Speakers. It was a pleasure to have Assembly President, Rev. Gregor Henderson present with us at this Celebration for part of the time and the General Secretary, Rev. Terence Corkin attended for the whole period. Past Moderators of the Uniting Church were also present (from Queensland, New South Wales, and Northern Synod).

Synod Committees were generous in supporting people with indigenous and ethnic backgrounds to take part in this Celebration.

### **Ecumenical / International Liaison**

This position holds responsibility for keeping in touch with similar organisations within partner churches and international bodies with which the Uniting Church has links. Noela Schloss, as Ecumenical/International Liaison Officer, has where possible maintained this contact.

We continue to be affiliated with the World Alliance of Reformed Churches (WARC) and the World Federation of Methodist and Uniting Church Women (WFM&UCW) and receive the publications *Reformed World* and *WARC Update* and *Tree of Life* from the WFM&UCW.

These publications keep us up-to-date with activities of the many partner churches as well as the situations and needs of communities in underdeveloped countries throughout the world. The WFM&UCW holds Non-Government Organisation (NGO) Status with the United Nations in a consultative capacity. The partner churches are continually in our prayers.

Although many of our groups are now not fund-raising entities it continues to astound me that millions of dollars are forwarded for mission. Groups are responsive to appeals for specific needs of neighbouring countries. Synod Committees engage in many activities, and all on a voluntary basis. They continue to support financially, prayerfully, and in a practical way wherever the need arises.

The South Australian Synod Committee endeavoured to fulfil the dream of a worker in Zambia by providing a small cuddly toy for each orphaned and vulnerable child in Mwandu. An appeal was launched and over 8,000 'cuddlies' were lovingly made. Cuddlies went to India, Thailand, and East Timor. This is certainly a testimony of love and care for our neighbours. Frontier Services, a sister Agency, is continually receiving support in many forms from our members, as is local Chaplaincy work in the schools and colleges.

Many other projects, too extensive to list individually, are a great witness to the various communities which receive the assistance. All these activities provide the stimulation of spiritual growth and discipleship. They are opportunities of witness to the wider community and allow through fellowship the recognition, development, and use of gifts in ministries of service. Just as Jesus' ministry challenged people to give more serious attention to the nature of service the 'volunteer' program is

renewing our commitment to Jesus' service'. It is just putting the presence of Jesus Christ into action.

### **National Consultation**

Toward the end of the triennium the National Committee is obliged to arrange a National Consultation (Business meeting) of the UCAF in Australia. The 10<sup>th</sup> National Consultation will be held in Brisbane 21 – 24 May 2009. The Assembly will send consultants and each of the Synod Committees three delegates, whilst Tasmania and the Northern Territory will send two. We are looking forward to the Assembly President being present for part of the time. It is unfortunate that, owing to commitments elsewhere, the General Secretary will be unable to attend. A vital part of the Consultation will be the discussion with Assembly representatives on how the UCAF can take part in the proposed *Generation Y* programme of the wider church.

The Commissioning of the new National Committee from New South Wales by the President of the Assembly will take place at Bayside Uniting Church, Manly West, Brisbane on Sunday, 24 May 2009.

We celebrated the 30<sup>th</sup> year of the Uniting Church during our term and were told - "The members are 'Pearls of Great Price'!"

During the triennium, as President I have been privileged to visit every Synod Committee and meet with many local groups in rural and metropolitan areas of Australia. I thank the many people who extended wonderful hospitality and it was my privilege to meet UCAF members in their home environment.

As well as sharing and enjoying devotional content and training, the practical projects and various pastoral care activities will continue to be part of our annual programmes. Fellowship groups provide a non-threatening environment within the church allowing many with a special need to find a place of solace.

Most groups are 'left to their own devices' within their local church and get on with their work and witness without very much publicity. A number of our affiliated groups are now mixed, male and female, and these groups, numerically, are amongst some of the most successful groups.

## UNITING CHURCH ADULT FELLOWSHIP NATIONAL COMMITTEE MANDATE

- Responsible to:** The Assembly
- Reporting arrangements:** The Assembly and the Standing Committee
- Mission Statement:** To facilitate the network of Adult Fellowships nationally in order to promote the mission and witness of the Uniting Church In Australia.
- Mandate:**
1. To foster and develop links with Synod committees of adult fellowships.
  2. To appoint representatives, as agreed with the General Secretary, to various ecumenical bodies such as Australian Church Women and international bodies such as World Federation of Methodist and Uniting Church Women, the World Alliance of Reformed Churches' Department of Partnership of Women and Men, and Bridgebuilders International.
  3. To organise and facilitate conferences and meetings of adult fellowships as appropriate.
  4. To consult and co-ordinate with other Assembly agencies on ways adult fellowships may participate and assist in the ongoing life and witness of the Uniting Church in Australia.
- General:** The responsibilities of every agency include:
- focusing the activities of the agency on the vision of the Assembly as a whole;
  - advising the Assembly and/or the Standing Committee on policy matters within their area of responsibility;
  - making policy decisions where the Assembly or the Standing Committee has delegated authority for certain policy areas, either through the agency mandate or by resolution;
  - participating in cross-agency projects and teams established by the Assembly or the Standing Committee.
- Power to appoint:**
- To establish working groups for special tasks related specifically to the mandate.
  - To make recommendations to the Standing Committee to establish other working groups for special tasks related to but not part of the mandate.
- Membership of the Reference Committee:**
- President and up to eleven members from one synod for each three year term (the Synod base to rotate each triennium), appointed by the triennial UCAF Consultation and noted by the Assembly or the Standing Committee;
  - power to co-opt to ensure appropriate competencies, representation and development of new leadership.
